

General Terms

VARIATION IN COMPUTER MONITORS. Due to the variation in all computer monitors, the exact colors and appearance of the photographic prints may not be reproduced accurately on your computer monitor. However, any variance, if present, should be slight.

RELEASES, ART COMMISSION AND GALLERY CONTRACTS will be executed for all work. Industry standard documents will be provided based in part or in whole on ASMP document models.

FEES are based on industry standards and local market conditions. Since my work is highly customized, individual estimates will be provided.

BILLING and PAYMENT. Normally 50% of a client's billing will be due at the time work begins, balance due on receipt of client's order. Commercial work payment is due net 30 days on unpaid balance. Advance payment may be required for significant expenses required for specific projects.

LIMITED EDITION photographic print. Contact James Frederick Bland for specific information on purchases. Unlimited Edition Images will be produced in one physical size closest to [16 x20 inches] mounted and matted only. Ltd. Editions will be customized to best suit the image. All images are printed to order.

FORMATS. Optically enlarged B&W prints are printed on fiber based double weight paper, archive mounted and single matted for framing in museum white matt board. On single image editions, custom arrangements can be offered.

PRICES are non-negotiable **RETAIL PRICES** if listed. Wholesale pricing is available for qualified vendors. All available images are printed in at least a 16 x20 inch format, mounted and matted for framing. Packaging, insurance and shipping are quoted separately quoted and charged at time of purchase.

SHIPPING. Prices do not include insurance, packaging and shipping and will be quoted at the time of a purchase regardless of method of purchase, normally about 10% addition to the retail pricing.

PAYMENT & CURRENCY. To reserve and/or order your selected photographic print, it must be paid for in full at the time of purchase. Prices will be quoted in USA dollars. Delivery will occur in 3-5 weeks or sooner depending on the current workload. Work will not proceed until funds are received and deposited.

RETURNS. Any purchase may be returned for a refund within 30 days of purchase for full credit minus a 25% restocking fee. Original packaging must be used and the image must be returned in original as shipped condition.

RECEIVING DAMAGED PACKAGING. Inspect the shipping carton before you open it. If there is damage to the PACKAGING, carefully open the container and check the artwork for damage. If the artwork is damaged, contact the shipper listed on the shipping label immediately, to arrange for an inspection.

LIMITATIONS OF LIABILITY. Liability for photographic services are limited to fees paid by the client for work. Expense fees are non refundable. Disputes not capable of a remedy will be submitted to arbitration.

For artwork, Liability is limited to the replacement of the artwork for a defect in the print preparation. The defective print will have to be returned before a replacement print is shipped.
